



A minimum of 6" round duct must be used to maintain maximum air flow efficiency.

Always use rigid type metal ducts only. Flexible ducts could restrict air flow by up to 50%.

Also use calculation (on page 8) to compute total available duct run when using elbows, transitions and caps.

ALWAYS, when possible, reduce the number or transitions and turns. If long duct run is required, increase duct size.

If turns or transitions are required; install as far away from hood duct output and as far apart, between the two as possible.

Minimum mount height between range top to hood bottom should be no less than 24". Maximum mount height should be no higher than 34".

It is important to install the hood at the proper mounting height. Hoods mounted too low could result in heat damage and fire hazard; while hoods mounted too high will be hard to reach and will lose its performance and efficiency.

If available, also refer range manufacturer's height clearance requirements and recommended hood mounting height above range.

- ► Fasten all connections with sheet metal screws and tape all joints w/ certified Silver Tape or Duct Tape.



## **Electrical Supply**



Electrical wiring must be done by qualified person(s) in accordance with all applicable codes and standards. Turn off electrical power at service entrance before wiring.

For personal safety, remove house fuse or open circuit breaker before beginning installation. Do not use extension cord or adapter plug with this appliance.

#### Follow national electrical codes or prevailing local codes and ordinances.

This appliance requires a 120V 60Hz electrical supply, and connected to an individual, properly grounded branch circuit, protected by a 15 or 20 ampere circuit breaker or time delay fuse. Wiring must be 2 wire w/ ground. Please also refer to the Electrical Diagram labeled on product.



## Mounting the Hood

# CAUTION

At least two installers are required due to the weight and size of the hood.

- Measure from range top to hood bottom and mark line A (24" minimum from range top).
- 2. Plum and mark center line.
- 3. Mark hood height line B. ZAN: 18-7/16" from line A

ZSA: 9-1/2" from line A ZRV: 15-7/8" from line A ZRO: 11-3/8 from line A

4. Mark mounting spread from C/L.

ZAN: 8-7/8" on line B ZSA: 9-7/8" on line B ZRV: 8-15/16" on line B ZRO: 12-5/8" on line B


5. Fasten (2) M6 x 1-1/2" screws into studs on line B but do not tighten all the way.

**NOTE:** Wood blocking may need to be added behind the druwall if no studs are present. Wall

anchors may also be used but check local codes for compliance. Failure to use suitable wall anchors and screws to hold the weight of the hood could result in personal injury or damage to the cooking surface or counter.



- 7. Hang hood onto the mounting screws and hand tighten each screw (FIG. B, A).
- 8. Center and attach duct cover mounting bracket to wall just below the ceiling or soffit using (2) M6 x 1" screws.
- 9. Install electrical and duct work. Seal duct work with aluminum duct tape.
- 10. Power up hood and check for leaks around duct tape.
- 11. Place telescopic duct covers onto hood and extend inner (top) duct cover upwards and secure to duct cover bracket using (2) M4 x 8 screws. Reinstall mesh filters.



## Mounting the Hood

- 12. ZRV : Lilft glass canopy and place on top of hood body, secure glass canopy to hood body by (4) 3/16 x 1/4 screws. Hand tighten screws.
- 13. \* If using hood in recirculating mode you must secure the air diverter plate onto wall before installing duct work and duct covers. You will also need to install charcoal filters and brackets. Turn to page 18 for more details.

#### **Ductless Recirculation**

Ductless recirculation is intended for applications where an exhaust duct work is not possible to be installed. When converted, the hood functions as a recirculating hood rather than an exhaust hood. Fumes and exhaust from cooking are drawn and filtered by a set of optional charcoal filters. The air is then purified and re-circulated back within the home.

We recommend to ALWAYS exhaust air outside of the home by employing existing or installing new duct work, if possible. The hood is most effective and efficient as an exhaust hood. Only when the exhaust option is not possible should you recourse to converting the hood into a recirculating hood.

When converted to be a recirculating hood, a set of charcoal filters are required on top of its standard Metal Filter set. Order according to its part number below. The standard mesh filters are intended to capture residue from cooking, and the optional charcoal filters help to purify fumes exhausted from cooking for recirculation.

## Recirculating Kit Installation (required if no ducting is used)

For detailed installation instructions, please refer to the manual included with the recirculating kit. The kit includes the charcoal filters, charcoal filter brackets, and air diverter plate.

## Recirculating Kit Installation (required if no ducting is used)

- 1. Purchase recirculating kit per the part number on the table.
- 2. Secure air diverter plate to wall below duct cover bracket. Run 6" ducting from top of hood and secure to air diverter plate (FIG. C).
- 3. ZAN: Remove aluminum mesh filters from hood. Secure charcoal filters to back side of aluminum mesh filter by 3 brackets (FIG C2).
- 4. ZSA, ZRV, ZRO: Remove aluminum mesh filters from hood. Secure charcoal filter brackets to the hood body behind each mesh filters using the screws included in the recirculating kit. Clip charcoal filters onto each charcoal filter bracket (FIG. C1).
- 5. Re-install mesh filters.
- 6. Charcoal filters must be replaced every 120 hours of use (or approximately every 3 to 4 months based on an average of 1 - 2 hours of daily cooking time).

DO NOT WASH CHARCOAL FILTERS. Charcoal filters may need to be changed more often depending on cooking habits.




#### **ICON Touch Controls**



#### 1 POWER / DELAY OFF BUTTON ()

#### **Power Button Function**

- OButton will turn power on and off for entire hood (fan and lights).
- Hood will remember the last speed and light level it was turned off at. (Example: Press Button to turn off hood when on fan speed 4 and high lights. Press Button again and the hood will turn back on at speed 4 and high lights level.)

#### **Delay Off Button Function**

- With the fan on press and hold the ① Button for two seconds. The fan will change to speed 1 and the 5 minute delay off timer will start.
  - + LEDs will illuminate and slowly blink in accordance with the time remaining until the fan and lights automatically turn off.
- Pressing () Button while Delay Off Function is enabled will turn the hood off and cancel the Delay Off Function.

#### **ACT Verification**

- Airflow Control Technology (ACT) allows the installer to set the maximum fan CFM to align with local codes and regulations.
  - To verify the maximum fan CFM:
    - With hood off, hold the ① Button for two seconds. If all five fan speed indicators illuminate = default maximum CFM. If four fan speed indicators illuminate = 390 maximum CFM. If 3 fan speed indicators illuminate = 290 maximum CFM.

#### 2 SPEED SELECTION BUTTON V

#### Fan Speed Decrease Button

- Press this button to decrease fan speed. 5, 4, 3, 2, 1.
- If fan is On Speed 1 and this button is pressed, fan will power Off.

#### Fan Speed Increase Button ^

- Press this button to increase fan speed. Fan On, 1, 2, 3, 4, 5.
- If hood is Off and this button is pressed, fan will turn On Speed 1.

#### **Act Enabled Speed Selections**

- When ACT is enabled, the number of fan speeds will be reduced as follows:
  - 390 CFM = Maximum 4 speeds
  - 290 CFM = Maximum 3 speeds

#### **ICON Touch Controls**

#### 3 LIGHTS BUTTON 🌣

- Lights have two levels, Low and High.
- From off, press one time for Low. Press again for High. Press again to power lights off.

#### **4 DISPLAY INDICATORS**

Mesh Filter Clean Reminder (always enabled)

- After 30 hours of fan usage, the V button indicator will begin to slowly blink indicating it is time to clean the mesh filters.
- To reset: With hood off: hold the ∨ button for three seconds. All LED indicators will blink two times confirming the 30 hour timer has been reset.

**Charcoal Filter Replace Indicator** (disabled by default, must be enabled if recirculating hood)

- To enable Charcoal Filter Replacement Reminder:
  - With hood off, hold ∧ button and ☼ button simultaneously for two seconds. All LED indicators will illuminate for three seconds confirming the Charcoal Filter Replace Reminder is enabled.
- To disable Charcoal Filter Replacement Reminder:
  - With hood off, hold ∧ button and ❖ button simultaneously for two seconds. All LED indicators will blink two times confirming the Charcoal Filter Replace Reminder is disabled.
- After 120 hours of fan usage the button will slowly blink indicating the char coal filters need replacment.
- To reset: With hood off, hold the ∧ button for two seconds. All LED indicators will blink two times confirming the 120 hour timer has been reset.


- 1. ZSA: Remove aluminum mesh filters.
- 2. ZAN, ZRO, ZRV: Locate PC board box on top of blower housing.
- 3. Remove 2-4 screws attaching PC board cover.
- 4. Connect the red wiring from the remote control control board to red connector in hood PC board.
- 5. Adhere remote control control board near PC board box.
- 6. The blue antenna wire needs to be extended for optimal signal. There is no need to secure it.

#### **Synchronization**

To create a unique link between your hood and remote control please follow these steps.

- 1. With hood off, press and hold the Lights button on the hood until the controls illuminate and flash.
- 2. Press a button on the remote, and the remote control will be synchronized with the hood.

#### **RF Remote Control Functions**



1 Blower On / Speed Selection

Press **\$\frac{1}{2}\$** to power on blower and cycle through all blower speeds.

2 Blower On / Power Off

By pressing  $\bigcirc$ , the blowers will power on at the last speed setting. Press  $\bigcirc$  again and the entire hood will power off, including lights.

Open Delay Off

By pressing (b), the blower and lights will enter Delay Off mode. The blower will change to speed 1 and a 5 minute timer will begin counting down.

Lights On/Dim/Off

Switch between light levels by pressing  $\maltese$ . Turn off the lights by cycling through the different light levels.



## **Optional RF Remote Control**

#### **RF Remote Features**

The RF remote control is equipped with a magnet on the back for easy storage. The remote may be placed on any magnetic surface such as a refrigerator or the Zephyr remote holder, FIG. D. The remote holder can be inserted into a standard electrical outlet for easy storage. Note: The remote holder does not charge the RF remote.

Maximum remote control communication distance is 15 feet from the liner.



#### **RF Remote Maintenance**

Clean the remote control using non abrasive detergents.

Follow instructions below for replacing battery. Using a small flat head screwdriver, raise the cover of the battery door (A) in order to access the battery compartment. FIG. E.

Remove the battery and replace with battery type A23 12V. Negative end of battery should face the spring inside the remote.

Re-install battery door and recycle old battery.



## **Hood & Filter Cleaning**

#### **Surface Maintenance**

- ▶ Do not use corrosive detergents, abrasive detergents or oven cleaners.
- Do not use any product containing chlorine bleach or any product containing chloride.
- ▶ Do not use steel wool or abrasive scrubbing pads which will scratch and damage surface.

#### **Cleaning Stainless Steel**

Clean periodically with warm soapy water and clean cotton cloth or micro fiber cloth. Always rub in the direction of the stainless steel grain. To remove heavier grease build up use a liquid degreaser detergent.

After cleaning use a non-abrasive stainless steel polish/cleaners, to polish and buff out the stainless luster and grain. Always scrub lightly, with clean cotton cloth or micro fiber cloth and buff in the direction of the stainless steel grain.

#### **Cleaning Grease Filters**

The grease filters installed by the factory are intended to filter out residue and grease from cooking. They need not be replaced on a regular basis but are required to be kept clean.

Remove and clean by hand or in dishwasher using a non-phosphate detergent. Discoloration of the grease filter may occur if using phosphate detergents, or as a result of local water conditions - but this will not affect filter performance. This discoloration is not covered by the warranty. Spray degreasing detergent and leave to soak if heavily soiled.

Dry grease filters and re-install before using hood.

- 2. Pull down on front of filter to remove the grease filters.



## **LumiLight LED**

In the unlikely event that your LumiLight LED fails, please contact Zephyr to order replacement parts.

#### LED Removal (FIG. G):

- 1. Remove grease filters.
- 2. Remove the side panels (if applicable) and remove the light panel.
- 3. Disconnect LED light quick connector.
- 4. Push in the two side clips on the ends of the LED light.
- 5. Push LED light through the light panel opening.



## Airflow Control Technology (ACT™)

Some local codes limit the maximum amount of CFM a range hood can move. ACT™ allows you to control the maximum blower CFM of select Zephyr Ventilation range hoods without the need for expensive make up air kits. ACT™ enables the installer to easily set the maximum blower speed to one of two most commonly specified CFM levels; 390 or 290 CFM. The usage of ACT™ may not be necessary for your installation. Please check your local codes for CFM restrictions.



Hood must be disconnected from the main power prior to performing the conversion instructions listed below. Failure to do so could result in personal injury or damage to the product.



After re-positioning the jumper and powering on the hood, the CFM cannot be changed again.


## Enabling ACT™

#### To enable ACT™:

- Before hood installation, gain access to PC board by following the steps shown on FIG. H.
- Change plastic jumper positioning as shown in FIG. I to set the desired maximum blower CFM.
- 3. Re-install PC board and continue with hood installation.
- 4. Remove the appropriate foil CFM sticker included with the hood literature and place inside the hood body below the wiring diagram or in another clearly visible location.

#### To verify if your installer enabled ACT™:

- 1. With hood off, hold the power button for three seconds. If 5 LEDs illuminate = default max. If 4 LEDs illuminate = max. 390 CFM, and if 3 LEDS illuminate = max. 290 CFM.
- 2. When ACT™ is enabled, the number of blower speeds will be reduced. 390 CFM = max. 4 speeds and 290 CFM = max. 3 speeds.
- 3. There should also be a foil label located inside the hood body near the wiring diagram that indicates the blower CFM.






document work.	Poor communication with the hood.	Remote control must be within 15 ft of hood.
	RF Remote lost communication with the hood.	Reset hood and remote by switching power off at the circuit breaker for 5 minutes. Place remote on counter top near the hood and switch the circuit breaker back on.
	Blue antenna wire is not extended.	Extend the blue antenna wire behind the light panel.


